<ul> <li>In pursuit of positive public relations, Mantorville Fire &amp; Rescue will be filling swimming pools and skating rinks, within Mantorville Fire &amp; Rescue's fire district only, with water purchased from the City of Mantorville. The following procedures will be considered and followed upon a request for said activities:         <ul> <li>Interested parties will make their request through the City of Mantorville via this request form available at Mantorville City Hall, 21 5th Street East, Mantorville, MN 55955 or by calling 507.635.5170.</li> <li>Requests will be communicated by City Staff to the Mantorville Fire Chief and/or Assistant Fire Chief.</li> <li>The Fire Chief and/or Assistance Fire Chief will coordinate with the interested party and a representative from the Fire Department to complete this action.</li> <li>For planning purposes, a pre-visit to the site will be conducted by the Mantorville Fire Department Member completing the fill. Water amounts will be recorded and communicated back to City Hall by the Fire Chief and/or Assistant Fire Chief for documenting on the requesting party's application.</li> <li>City Staff will contact the Property Owner with the total amount due.</li> <li>Delivery will not be made until payment is received. Payment is by cash or check only payable to the City of Mantorville.</li> <li>Fees are as follows:</li></ul></li></ul>
