Canvassing Results of the 2022 General Election

BACKGROUND INFORMATION:

The City Council shall meet as the Canvassing Board to review and certify the results of the 2022 General Election. For the Canvassing Board's review, attached is the Abstract of Votes Cast in the Precinct of the City of Mantorville, State of Minnesota, at the State General Election Held on Tuesday, November 8, 2022.

On Election Day, there were 815 Mantorville City registered voters at 7:00 am. Another 26 persons registered to vote on Election Day. A total of 607 voted during the 2022 General Election on November 8th – a 72% turn out of our Mantorville voters.
