TENNESSEN WARNING

In Accordance with the Minnesota Government Data Practices Act, the City of Mantorville is required to inform you of your rights as they relate to the private information collected from you.

The Purpose and Intended use of the information collected

The information we collect about you is classified by law as either public (anyone can see the information), or private (only you can see the information), or confidential (you cannot see the information).

The purpose and intended use of this is to aid the City of Mantorville in determining your qualifications to the committee you have selected or as an election judge.

May you refuse or are you legally required to Supply the Information we ask for? What are the Consequences of your Supplying or Refusing to Supply the Information?

You have the right to refuse to supply the information requested and there is no legal requirement that you provide the information requested.

If you supply the information requested, it will aid the City of Mantorville in determining your qualifications essential appointment on a committee or as election judge.

If you refuse to supply the information, your application may be considered incomplete and may disqualify you from being appointed to a committee or election judge.

Who has Access to the Private and Confidential Information we collect About You?

Individuals within the Clerk's Office of the City of Mantorville and individuals within the Committee seeking to fill the position. The City Council of the City of Mantorville will also have access to the information.

Individuals or agencies for which a state statute, federal law or the State Commission of Administration authorizes a new use or sharing of the information after you have been given this notice.

Unless otherwise authorized by state statute or federal law, government agencies with which we share private or confidential information may also treat the information they receive as private or confidential.
